What to do with your Provisional Allotment Letter and Excess Application Form

Option 1:

Take up all your nil-paid Rights Shares

DEADLINE

- 1. Unless otherwise agreed by the Company, make out a crossed cheque or obtain a cashier's order in Hong Kong dollars payable to "1010 Printing Group Limited PAL" for the full amount indicated in Box C of Form A on page 1 of your Provisional Allotment Letter. Option 2:
