### **INSIDE INFORMATION – DELISTING OF OPUS GROUP LIMITED FROM THE AUSTRALIAN SECURITIES EXCHANGE LIMITED**

This joint announcement is made by Lion Rock Group Limited (“**Lion Rock**”) and Left Field Printing Group Limited (“**Left Field**”) pursuant to Rule 13.09(2)(a) of the Listing Rules and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

Following the implementation of the scheme of arrangement approved by the shareholders of OPUS Group Limited (“**OPUS**”) on 6 September 2018 and the Federal Court of Australia on 13 September 2018, ASX has issued its formal decision resolving to remove OPUS from the Official List of the Australian Securities Exchange Limited and OPUS will be removed from the Official List of the Australian Securities Exchange Limited at the close of trading on Tuesday, 9 October 2018. OPUS will remain as a non-wholly owned subsidiary of Lion Rock and a wholly-owned subsidiary of Left Field and the financial results of OPUS will continue to be consolidated into the consolidated financial statements of Lion Rock and Left Field respectively.
