**CLARIFICATION ANNOUNCEMENT**

Reference is made to Note 39(a) of the financial statements of 1010 Printing Group Limited (the "Company") for the year ended 31 December 2014, which forms part of the annual report 2014 (the "Annual Report") of the Company dated 27 February 2015 and concerns the acquisition of OPUS by the Group. Unless otherwise expressed, the capitalised terms defined in the Annual Report shall carry the same meanings in this announcement.

The Company noticed an inadvertent error on the figures shown in the second sentence of the fourth paragraph on page 77 of the Annual Report, which reads: "*If the acquisition had occurred on 1 January 2014, Group revenue and loss would have been HK\$771,265,000 and HK\$140,942,000 respectively.*".

The Company wishes to clarify that the second sentence of the fourth paragraph on page 77 of the Annual Report should be read as "*If the acquisition had occurred on 1 January 2014, the Group should account for OPUS's whole year's revenue and loss of HK\$ 771,265,000 and HK\$ 140,942,000 respectively. The Group's revenue and loss would have been HK\$1,966,461,000 and HK\$1,411,000 respectively.*".

Save as disclosed above, all other information in the Annual Report shall remain unchanged.
